Article 4:

To discuss Pelletier Island Secession presentation

Selectmen Banville proposed a formula to calculate the yearly appropriation to the Island Association which would take the percentage of the Public works budget which deals with roads (about 85% of the budget) divided by the miles of town roads to get a price per mile. That amount per mile would then be multiplied by the length of Island Rd and the causeway to get the appropriation amount per year. Decisions on this article will be discussed at a later meeting when all board members are present.

To discuss ME PERS reserve account

The Town Manager explained that regular yearly transfers from the ME PERS reserve account had not been made in the last two years. She informed the board that the auditors suggested it would be possible to transfer the entire amount of that reserve account to the unappropriated surplus account to eliminate that process. Selectperson Sirois suggested to set up accounting in Trio which would pull the expenses of ME PERS monthly from a general ledger account instead of an expense account and do the transfer as the auditors suggested.
