Article 3:

To discuss appropriation proposal with Pelletier Island Association

Christy Sirois began by summarizing the proposal to the Secession Committee. She further explained the thought process behind the proposal and the consultation with the Budget Committee. Reno Pelletier inquired as to if the Town's plow equipment would be doing the winter work on the Island and Beurmond Banville explained that the proposal was purely for additional funding and not equipment services. Marc Nadeau questioned if the Town could facilitate the bid process for contracting plowing services to the Island and calcium orders. The board, by consensus, agreed to this. The Town Manager asked if the Island Association could provide the Town Office with last year's figures paid out for plowing services and calcium to get an idea for the biding process. Marc said he would provide those numbers to the Town. Pierre Dubay asked if the Town could put money aside in a reserve account for future road projects. Ryan Pelletier answered by reiterating that part of the proposal. Ryan also asked if the Town could look into laws surrounding having a separate mil rate for Island residents. The difference of that mil rate and the mil rate set for the rest of the Town would be appropriated back

to Island residents for road maintenance and other infrastructure projects. The Town Manager will look into this. The Town Manager will have the Public Works Foreman measure the exact length of the Island Road and Causeway. The Secession Committee ended by saying they would meet and discuss the proposal.

Article 4:

To discuss Spectrum Franchise Agreement

Shelley from Spectrum conferenced in. The Town Manager explained there were a few questions the board wanted answered before signing a new agreement. Their first request being the agreement remain a 5-year agreement instead of the 10-year written on the new agreement. Shelley said she would change it. Beurmond Banville then addressed service issues he's been experiencing such as service cut outs and the Spectrum office in Madawaska closing. Shelley said the intentions of the company is to open kiosks in the St John Valley to offer assistance for parts. She also said they could look in to construction problems in the area that may need to be addressed and repaired. She said we could look into a coverage survey to let us know what areas of Town could be reached. The Town Manager explained NMDC is doing this right now with a regional Connect ME grant effort to bring broadband to areas that don't have it right now. Shelley will send the Town Manager a revised copy of the agreement which the board will review at the next meeting.

Article 5:

To discuss office hours

The Town Manager explained it's become a common complaint in the office that customers can't make it to the office during regular operating hours. The Town Manager provided the board with a proposal for longer hours one day during the week and a half day on Friday. The board discussed having the Deputy Clerk work 9:30-6 on Thursdays for a trial period of 3 months beginning April 4th. The Town Manager will do ample advertising to let the public know of this change as well as inform the Deputy Clerk.
