MINUTES**

**Public Hearing – GA Ordinance & Winter Road Closing Order**

There was no one in attendance for the public hearing and no written comments were received. Public hearing closed at 6:35pm.

**Board of Selectmen Meeting**

Chairman Bechard called the meeting to order and established a quorum at 6:35pm.

**Article 1 - Minutes**

August 30, 2012 & September 10, 2012 – Motion by Mr. Banville and seconded by Mr. Chamberland to approve both sets of minutes as written. All approved.

**Article 2 - Financial Reports**

Period ending September 30, 2012 – Motioned by Mr. Banville and seconded by Mr. Chamberland to approve the financial reports as presented. All approved.

**Article 3 – 2012 MVR**

Ms. Sirois presented the board with a copy of the proposed 2012 Municipal Valuation Return. This is submitted annual to the State of Maine, Property Tax Division. The Town's reimbursement for Tree Growth and exemptions are calculated from this document. Document includes values of exemptions granted by the town and various town values of property and land. Motioned by Mr. Banville and seconded by Mr. Chamberland to approve the 2012 as presented with one correction on page 3, question 24-1 which is to answer the question "yes". All approved. Ms. Sirois will send to the State.

**Article 4 – Winter Road Closing Order**

Being there were no comments from the public hearing and no written comments received, Mr. Banville motioned and Mr. Chamberland seconded to approve the Winter Road Closing Order as presented. All approved. Ms. Sirois will file a copy with the registry of deeds.

**Article 5 – General Assistance Ordinance**

Annually the Appendices for the General Assistance are adopted as costs and policies change. At this time only Appendix C – Housing Maximums was updated due to legislation passed this year. Back in June Appendix A was updated. Motioned by Mr. Banville and seconded by Mr. Chamberland to approve Appendix C as submitted and recommended by the Maine Municipal Association. All approved.

**OTHER BUSINESS**

**Fire Department Old Rescue Truck Bid**

Only one bid was received from Gerard Chasse of St Agatha. His bid is for \$465.50. Mr. Banville motioned and Mr. Chamberland seconded to approve the bid pending the Fire Department Chief's review, to allocate the funds to go to the Fire Department and authorize Ms. Sirois to sign any and all necessary paperwork for the sale of the 1972 Chevy Step Van. All approved. The Fire Chief has since the Board meeting reviewed and told the Town Manager the bid was acceptable. Ms. Sirois will contact Mr. Chasse and finalize any necessary paperwork.

**Sewer Project Update**

Ms. Sirois told the Board that the Phase I work (Main Street) is nearly done and that there is just paving and lawn work to complete. All the replacements went well. Ms. Sirois said that Phase II is up and going. Work is being done at the sites that effect US Route I and 162 first because of permit and paving deadlines. Everything seems to be progressing and there are no issues so far. The next construction meetings are on October 23 at 1pm and 1:30pm.

Having no further business the meeting was adjourned at 7:18pm.



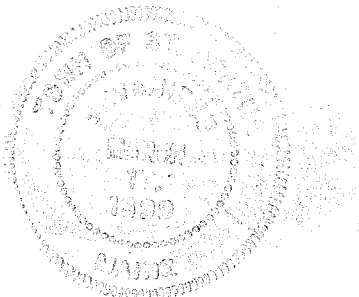
